1. Applicant must hold an active primary HRRRA membership in good standing.
2. No person may receive the Outstanding Rookie Award more than once.
3. An applicant may not have been previously licensed in Virginia or any other state.
4. An applicant must qualify for and receive an individual HRRRA Circle of ExcellenceSM award.
5. A recipient must meet the criteria for the minimum of a Bronze Award during his/her first twelve (12) months from date of licensure in any state, based on the COE criteria in effect at date of licensure.
6. Receipt of the Outstanding Rookie Award must be no later than the awards issuance immediately following the end of the first twelve (12) months of licensure.
7. A copy of the applicant's license(s) must accompany the award application.
8. All requirements and guidelines for the Circle of ExcellenceSM Award Applications must also be met.
9. The appropriate fee must accompany the application.
10. The application and Property Data Form encompassing the first twelve (12) months of licensure must be submitted to the Awards Committee before **5:00 p.m., Monday, February 1, 2021**, c/o HRRRA 638 Independence Parkway, Suite 100, Chesapeake, VA 23320

Period covered for this award must be no later than the deadline for COE award application that follows the end of the first twelve (12) months of licensure.
